Mission statement

The mission of the IUCN SSC Marine Conservation Committee is to support, enhance and mobilise expertise in marine species conservation for a better future. Its mandate is to ensure that decisions on marine species are directed at long-term population health and based on sound technical knowledge. Specifically, it helps and links volunteer experts from the IUCN Species Survival Commission's (SSC) network who have special knowledge of particular taxa or of cross-cutting concerns. It also advocates the use of SSC marine knowledge and skills in the broad global community, particularly by policy makers and resource managers.

Projected impact 2021–2025

The Marine Conservation Committee will lead and support the creation of at least 10 new marine species Specialist Groups and a fisheries Task Force. The committee will support new and existing species Specialist Groups by assessing best practices among marine groups and collating this information for implementation by other groups.

The Conservation Planning Specialist Group will be supported by the committee in order to increase marine capacity in conservation planning. Resolutions on critical marine issues, including emergency resolutions, will be supported for the 2024 World Conservation Congress.
