

TERMS OF REFERENCE PURPOSE AND OBJECTIVES TASK FORCE ON OTHER EFFECTIVE AREA-BASED CONSERVATION MEASURES

Background

In 2010, the 10th Conference of the Parties to the Convention on Biological Diversity (CBD COP 10) adopted the Aichi Biodiversity Targets as part of the *Strategic Plan for Biodiversity 2011-2020*. Target 11 calls for "at least 17 per cent of terrestrial and inland water areas and 10 per cent of coastal and marine areas" to be conserved by way of "well-connected systems of protected areas *and other effective area-based conservation measures*" (OECMs). Through this and subsequent CBD Decisions, the Parties requested IUCN and other organizations to provide technical advice on implementation of Target 11 including the provision for OECMs.

In 2015, WCPA established a Task Force to develop technical guidance. The Task Force aims to finalise the guidance in time to be considered at meetings of the CBD's Subsidiary Body on Scientific, Technical and Technological Advice and to be referred to in the Decisions of CBD COP 14 in 2018.

It will continue to solicit further support for the work of the Task Force.

The Task Force's members communicate with each other though a listserv, its meetings outcomes and

consultations documents are posted on a dedicated <u>webpage</u> and reports are sent to the Protected Planet newsletter for circulation to the wider membership of WCPA.
